Andy Fraizer, executive director of the Indianapolis-based Indiana Association for Community Economic Development, has been selected to join The Federal Reserve Bank of St. Louis Community Development Advisory Committee. The Advisory Committee meets twice a year to inform St. Louis Federal Reserve Bank President James Bullard about relevant issues and suggest ways the Bank might support development efforts in local communities. The St. Louis Fed notes that the Community Development Advisory Committee is a very valuable mechanism for providing insights into the challenges and opportunities facing the community development field in the Eighth Federal Reserve District.
