HB 1541 & End of Session Update

HB 1541, a trailer bill for SEA 148, has been passed in both chambers and is on its way to Governor Holcomb's desk for signing. The bill will remedy two of the [problems](#) created when SEA 148 was enacted into law in February. Look for a PI press release when the bill is signed into law. State of Indiana Action Plan

The State of Indiana draft [2021 Action Plan](#) is open for comment through May 13. Keep an eye out for an email on the Prosperity Indiana comment process.

Homeowner Assistance Fund

It is confirmed that Indiana Housing and Community Development Authority (IHCDA) will be applying for Indiana's allocation of \$167,921,663 from \$10 billion of the [Homeowner Assistance Fund](#). This Fund is from the American Rescue Plan Act.

CFPB Interim Final Rule on Debt Collection & Eviction Moratorium

The Consumer Protection Financial Bureau (CFPB) has [released an interim final rule](#) on debt collection practices during COVID-19. According to the CFPB, the rule requires debt collectors to provide written notice to tenants of their rights under the eviction moratorium and prohibits debt collectors from misrepresenting tenants' eligibility for protection from eviction under the moratorium. It will go into effect on May 3, 2021. [View the interim final rule here.](#)

Eviction Moratorium

The [CDC Eviction Moratorium has been extended](#) until June 30, 2021. Residents who previously submitted a declaration to their landlord should not be asked to resubmit and should have continued protection until June 30. - The Indiana Legal Services Tenant Help Desk hotline is available every Thursday from 11 a.m. to 1 p.m. for the remainder of 2021. [For more information, view the flyer.](#)
- For [Mortgage Assistance](#), Indiana's Hardest Hit Fund (HHF) is available to help Indiana homeowners who have fallen behind on their mortgage payments or who are unable to

make future payments. [The deadline to apply is May 3, 2021.](#)

- The [Indy Affordable Modification Program \(IndyAMP\)](#) allows Marion County homeowners negatively affected by COVID-19 to refinance mortgage debt at a below-market interest rate for up to 30 years. IndyAMP allows owners to remain in their homes, become current with their mortgages, and lower their monthly payments.
- Applications are being accepted for [Low-Income Home Energy Assistance Program \(LIHEAP\)](#). LIHEAP provides a one-time annual benefit to help with the high cost of home energy. An additional \$350 CARES Act benefit is also available to qualifying households experiencing a reduction in income due to COVID-19. The last day to apply is May 14, 2021.

P PROGRAMS

Indiana Assets & Opportunity Network

Prosperity Indiana is working with our Indiana A&O Network partners to advocate for policies that will allow Hoosiers to 'rebuild better' assets and opportunities following the pandemic. Recent advocacy efforts have included urging Congress to overturn the Office of the Comptroller of the Currency's (OCC) "fake lender" rule. This regulation was approved in 2020 and preempts state usury laws if a national bank is named as the lender on the loan agreement. The rule could protect loans charging high annual percentage rates (APR) approaching 200% APR or more that are laundered through a bank to evade state- and voter-approved interest rate caps. The Indiana Assets & Opportunity Network creates learning opportunities for community leaders, advocates for policies that affect low-to-moderate income families, and builds capacity for organizations aimed to increase financial stability. It is co-led by Prosperity Indiana and the [Indiana Institute for Working Families \(IIWF\)](#), which is a program of the Indiana Community Action Association skilled in research, policy analysis, and advocacy.

IU Researchers to Study Farm Ownership

The U.S. Department of Agriculture (USDA) has awarded researchers from Indiana University a \$500,000 grant to study ways that the government can encourage new farm ownership among young and beginning farmers, farmers of color, and women.

The article states that, "According to the project proposal, 70,000 new farms are started in the U.S. every year. New farmers help to bring prosperity to rural communities and make outsized contributions to sustainable agriculture. However, they also face significant obstacles when trying to obtain land." The project's goal is to help revitalize rural communities.

General Information & Precautions

- Wash your hands for 20 seconds.
- Clean and disinfect frequently touched surfaces daily.
- Avoid touching your face.
- Encourage teleworking when feasible.
- Practice social distancing when possible and avoid close contact with others. This may include staggering work schedules and decreasing social contact in the workplace.

Decisions about the implementation of community measures will be made by local and state officials, in consultation with federal officials as appropriate, and based on the scope of the outbreak and the severity of illness. Implementation will require extensive community engagement with ongoing and transparent public health communications (CDC).

Prosperity Indiana's Response

Since July 15, 2020, Prosperity Indiana team members have been able to return to the office to work. Staff will be rotating days that they are present in the office. While most team members continue to work remotely at this time, we have compiled the following information about our return to work plan.

Our re-opening plan includes:

- Limiting staff in the office to no more than three at a time and fewer than 10 short-term, staggered visitors daily to allow for physical distancing
- Providing adequate PPE for staff and visitors, along with extra hand sanitizing supplies, tissues, and wipes for high touch surfaces.
- Implementing a return-to-work plan that complies with the Back on Track Roadmap, CDC, Indiana Department of Health, and OSHA guidelines.
